RE: Intergovernmental Agreement by and between the Cook County Sheriff's Office and the Metropolitan Water Reclamation District of Greater Chicago for the Expansion of the Prescription Drug Take Back Program

Dear Ms. McElligot,

Pursuant to Article 20 of the above-referenced Intergovernmental Agreement ("IGA"), please allow this correspondence to serve as the Cook County Sheriff's Office's ("CCSO") full satisfaction of the reporting terms of the IGA, as well as the CCSO's formal request to continue our partnership through a renewed IGA.

By way of background, on June 29, 2016 the Cook County Board of Commissioners approved the IGA between the CCSO and the Metropolitan Water Reclamation District ("MWRD") in order to expand the impact and scope of the Prescription Drug Take-Back Program (hereinafter the "Program"). The CCSO oversees and administers the Program, collecting and disposing of pharmaceutical drugs across Cook County in order to reduce environmental contamination.

The Sheriff's Office has engaged with and surveyed over 130 local law enforcement agencies regarding the Program, and thus far has secured the participation of nearly fifty municipal sites for receptacle deployment. Attached hereto you will find the requisite annual report with an overview of secured collection sites, as well as the amount of prescription drugs collected and destroyed thus far as the Program has fully gotten underway.



Please also fine enclosed for your convenience (1) all applicable Certificates of Destruction and (2) a proposed IGA for year 2017-2018. Finally, one master invoice has been generated to encompass the amount due pursuant to the IGA. Specifically, one (1) month of staffing reimbursement costs has been billed in addition to the costs of all Sheriff's Office receptacles purchased and deployed. Please disregard all prior invoices received pursuant to this IGA.

Sheriff's Office Prescription Drug Take Back Program Annual Program Evaluation

June 9, 2017

Purpose

This report is intended to assess the effectiveness of the Prescription Drug Take-Back Program of the Cook County Sheriff's Office (the "Program") in preventing pharmaceutical drugs from entering Illinois waterways, as required by Article 2F of the Intergovernmental Agreement ("IGA") between the Metropolitan Water Reclamation District of Greater Chicago (the "District"), and the Cook County Sheriff's Office (the "Sheriff's Office").

Overview

Administration of the program since the execution of the IGA has been focused on securing municipal partner sites for receptacle deployment and developing the Program itself. This phase has consisted of the design and development of prescription drug take back receptacles, design of educational outreach initiatives for the benefit of the public regarding the Program and receptacle locations, and outreach to suburban jurisdictions. Collection of drugs from receptacles commenced on or around September of 2016, with the Program expanding on a rolling basis as additional municipal sites were secured. Included and attached herein you will find details regarding all secured collection sites as of the date of June 1, 2017, as well as the amount of prescription drugs collected and destroyed from each site and geographical region.

<u>Total Law Enforcement Agencies Surveyed</u>: 133 individual municipalities across Cook County, relevant findings summarized as follows:

- 10 jurisdictions neither collect pharmaceuticals occasionally or permanently;
- 51 jurisdictions collect occasionally;
- 18 jurisdictions collect permanently;
- 70 of the 81 that actively responded to the survey expressed interest in participation with collection and destruction; 10 have alternate means of collection and destruction, but are willing to share data; and
- Of the 70 jurisdictions that actively responded, 5 had existing and functional receptacles.

Total Number of Sheriff's Office Receptacles Deployed: 40

Total Amount of Prescription Drugs Collected: 2117.5 lbs.

Total Amount of Prescription Drugs Destroyed: 1734.5 lbs.

Conclusion

Activity over the last year pursuant to the IGA has focused primarily on recruiting local law enforcement agency partners, executing applicable Partner Site Memorandums of Understanding, and designing and deploying collection receptacles. Recent and future activity will now transition to ongoing operation of the Program, including collection and destruction of pharmaceuticals from collection sites. The Sheriff's Office will continue to recruit additional law enforcement partners, particularly in light of the Cook County Board of Commissioners' passage of Cook County Ordinance 16-1983, which mandates the engagement of pharmaceutical companies in the Program through development of collection plans with the Cook County Sheriff's Office.
