ORDINANCE AMENDING ORDINANCE ESTABLISHING THE RIGHT-OF-WAY FOR THE CONSTRUCTION, OPERATION, AND MAINTENANCE OF THE McCOOK LEVEE SECTION 205 FLOOD RISK MANAGEMENT PROJECT PARTNERSHIP AGREEMENT IN THE VILLAGES OF McCOOK AND SUMMIT, ILLINOIS IN PART OF SECTION 11, TOWNSHIP 38 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN IN COOK COUNTY, ILLINOIS

WHEREAS, the Board of Commissioners of the Metropolitan Water Reclamation of Greater Chicago ("Board"), on July 11, 2009, adopted Ordinance R19-003 entitled "Ordinance Establishing the Right-Of-Way for the Construction, Operation and Maintenance of the McCook Levee Section 205 Flood Risk Management Project Partnership Agreement in the Villages of McCook and Summit, Illinois in part of Section 11, Township 38 North, Range 12, East of the Third Principal Meridian in Cook County, Illinois; and

Whereas, it is necessary to acquire additional permanent or temporary easements or fee simple title not previously identified in said Ordinance R19-003 as right-of way for the construction, operation and maintenance of the McCook Levee Section 205 Flood Risk Control Management Project Partnership Agreement in the Village of Lyons in parts of Sections 6, 7 and 12, Townships 37 and 38 North, Ranges 12 and 13, east of the Third Principal Meridian in Cook County, Illinois;

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the Metropolitan Water Reclamation District of Greater Chicago:

- Section 1. That Ordinance R19-003, entitled "Ordinance R19-003 Establishing the Right-of-Way for the Construction, Operation and Maintenance of the McCook Levee Section 205 Flood Risk Management Project Partnership Agreement in the Villages of McCook and Summit, Illinois in part of Section 11, Township 38 North, Ranges 12, East of the Third Principal Meridian in Cook County, Illinois", be incorporated by reference herein and is made a part hereof as set forth in full.
- Section 2. That the legal descriptions set forth in Exhibit A to Ordinance R19-003 be and the same are hereby amended by adding thereto the real estate legally described in Exhibit AA, which is attached hereto and made a part hereof.
- Section 3. That henceforth Ordinance No. R19-003 shall be known as "Ordinance establishing the right-of-way for the Construction, Operation and Maintenance of the McCook Levee Section 205 Flood Risk Management Project Partnership Agreement in the Villages of McCook, Summit and Lyons, Illinois in parts of Sections 6, 7, 11 and 12, Townships 37 and 38 North, Ranges 12 and 13, East of the Third Principal Meridian in Cook County, Illinois, as amended."

Section 4. That except as amended hereby, Ordinance R19-003 shall be in full force and effect from after its passage.

Section 5. This Ordinance shall be in full force and effect from and after its passage.
