Authority to increase purchase order and amend the agreement with SBC Global Services, Inc., d/b/a AT&T Global Services, Inc., for Contract 10-RFP-15 Local and Long Distance Telephone Service, in an amount of \$31,200.00 from an amount of \$1,195,385.32 to an amount not to exceed \$1,226,585.32, Account 101-27000-612210, Purchase Order 3069592

Dear Sir:

On June 16, 2011, the Board of Commissioners authorized the Director of Procurement and Materials Management to issue a purchase order and enter into an agreement for Contract 10-RFP-15 Local and Long Distance Telephone Service with SBC Global Services, Inc., d/b/a AT&T Global Services, Inc., in an amount not to exceed \$900,000.00. The contract expires on February 29, 2016.

As of February 4, 2016, the attached list of change orders has been approved. The effect of these change orders resulted in an increase in the amount of \$295,385.32, from the original amount awarded of \$900,000.00. The current contract value is \$1,195,385.32. The prior approved change orders reflect a 33% increase to the original contract value.

The District will need an additional \$31,200.00 to fund four months of Local and Long Distance service while Request for Proposals are completed allowing a possible technology replacement saving the District on Local and Long Distance calling services.

This change order is in compliance with the Illinois Criminal Code since the change is due to circumstances not reasonably foreseeable at the time the contract was signed, and is in the best interest of the District.

It is hereby recommended that the Board of Commissioners authorize the Director of Procurement and Materials Management to execute a change order to increase the purchase order and amend the agreement in an amount of \$31,200.00 (3% of the current contract value), from an amount of \$1,195,385.32 to an amount not to exceed \$1,226,585.32.
