RESOLUTION sponsored by the Board of Commissioners recognizing the 50th Annual Chicago Business Opportunity Fair

WHEREAS, the Chicago Minority Business Development Council's historic 50th Annual Chicago Business Opportunity Fair will be held April 20th through April 21st at the Hyatt Regency Chicago; and

WHEREAS, the Chicago Business Opportunity Fair has a distinguished history as a catalyst for developing partnerships between minority and majority owned corporations and government agencies; and

WHEREAS, the Chicago Business Opportunity Fair is the nation's first and region's largest conference and trade fair connecting qualified, certified minority suppliers with corporate and government buyers; and

WHEREAS, continuing its tradition of promoting relationships between minority owned businesses and major buying organizations in the public and private sectors, more than 2,000 corporate executives, minority business owners, and government officials participate in the Fair each year; and

WHEREAS, the Metropolitan Water Reclamation District of Greater Chicago has been a pioneer in recognizing economic contributions of minority businessmen and businesswomen; and

WHEREAS, this recognition is evidenced by the Metropolitan Water Reclamation District of Greater Chicago's adoption and continuing advocacy of a policy which supports the legitimate aspirations of minority communities and businesses within its jurisdiction; and

WHEREAS, the development of minority business enterprise is of monumental importance and worthy of encouragement and acknowledgement; and
