#### Dear Sir:

On July 6, 2017, the Board of Commissioners authorized the Director of Procurement and Materials Management to advertise for bids, Contract 17-029-11 furnish and deliver safety equipment to various locations for a one (1) year period, beginning approximately November 1, 2017 and ending October 31, 2018.

In response to a public advertisement of July 19, 2017, a bid opening was held on August 15, 2017. The bid tabulation for this contract is:

Three hundred sixty-one (361) companies were notified of the contract being advertised and fifty-six (56) companies requested specifications.

Dival Safety Equipment, Inc., the lowest bidder, did not bid all items as required in the general terms and conditions. Therefore, the bid was considered non-responsive and was rejected. The Director of Procurement and Materials Management has notified Dival Safety Equipment, Inc. of this action.

Fisher Scientific Company, L.L.C., the lowest responsible bidder, is proposing to perform the contract in accordance with the specifications. The estimated cost for this contract was \$110,000.00, placing their bid of \$103,978.17 approximately 5.5 percent below the estimate.

The Multi-Project Labor Agreement (MPLA) is not applicable to this contract because it is primarily a furnish and deliver contract.

The Affirmative Action Ordinance, Revised Appendix D is not included in this contract because it is primarily a furnish and deliver contract.

In view of the foregoing, it is recommended that the Director of Procurement and Materials Management be authorized to award Contract 17-029-11 to Fisher Scientific Company, L.L.C., in an amount not to exceed \$103,978.17.

Purchase orders will be issued when material is required. Payment will be based on the unit cost as indicated in the contract documents. There was no bid deposit required for this contract. Funds are available in Account 101-20000-623700.
