Authority to pay 2017 real estate taxes in the amount of \$583,278.02 for Metropolitan Water Reclamation District of Greater Chicago's real estate located in Will County, Illinois. Account 101-30000-667130

Dear Sir:

Pursuant to the Illinois Property Tax Code, 35 ILCS 200/15-143, the District is responsible for the real estate taxes on land owned and located outside of Cook County, unless specifically exempt.

The District has now received the 2017 real estate tax bills for its non-exempt real estate in Will County, Illinois. The property consists 21 separate permanent index numbers. The total 2017 taxes for the subject parcels is \$583,278.02 and of that amount \$527,744.62, or 90.48%, is attributable to the Will County Locks and Lockport Powerhouse.

The first installment of the 2017 taxes in the amount of \$291,639.01 is due on or before June 4, 2018, and the second installment in the amount of \$291,639.01 is due on or before September 4, 2018.

Accordingly, it is requested that the Executive Director recommend to the Board of Commissioners that it authorize and approve the timely payment of the 2017 real estate taxes on the District's non-exempt property in Will County, Illinois, in the aggregate amount of \$583,278.02, in one installment of \$291,639.01 due on June 4, 2018, and one installment of \$291,639.01 due on September 4, 2018.

It is further requested that the Executive Director recommend to the Board of Commissioners that it authorize and direct the Chairman of the Committee on Finance and the Clerk to issue two checks in the amount of \$291,639.01 each; one check before June 4, 2018, and one check before September 4, 2018, payable to the

Will County Collector on account of the 2017 real estate taxes on District's non-exempt property in Will County, Illinois.
