Dear Sir:

On April 5, 2007, the Board of Commissioners authorized the Director of Procurement and Materials Management to award Contract 07-668-11 Installation and Maintenance of Native Prairie Landscape at the Egan Water Reclamation Plant, to McGinty Bros., Inc., in an amount not to exceed \$83,000.00. The contract expired on December 31, 2009.

This contract has no prior change orders.

A decrease in contract value is being requested at this time because the utilization of the contract services in 2009 was less than originally anticipated.

This change order is in compliance with the Illinois Criminal Code since the change is due to circumstances not reasonably foreseeable at the time the contract was signed, and is in the best interest of the District.

It is hereby recommended that the Board of Commissioners authorize the Director of Procurement and Materials Management to execute a change order to decrease Contract 07-668-11, in an amount of \$15,100.00 (18.2% of the current contract value), from an amount of \$83,000.00, to an amount not to exceed \$67,900.00.
