Dear Sir:

On March 15, 2007, the Board of Commissioners authorized the Director of Procurement and Materials Management to issue a purchase order and enter into an agreement for Contract 06-RFP-26, Legal Services for Workers' Compensation Defense with Nyhan, Phister, Bambrick, Kinzie & Lowry PC, in an amount not to exceed \$150,000.00. The contract expired on December 31, 2008.

This contract has no prior change orders.

The purpose of this change order is to reduce and close the purchase order.

This change order is in compliance with the Illinois Criminal Code since the change is due to circumstances not reasonably foreseeable at the time the contract was signed, and is in the best interest of the District.

It is hereby recommended that the Board of Commissioners authorize the Director of Procurement and Materials Management to execute a change order to decrease the purchase order and amend the agreement in an amount of \$114,065.89 (76.04% of the current contract value), from an amount of \$150,000.00, to an amount not to exceed \$35,934.11.

Funds will be restored to Account 101-30000-601170.
