The Government Finance Officers Association of the United States and Canada (GFOA) recently awarded the District the Distinguished Budget Presentation Award for the 2009 Budget and Certificates of Achievements for Excellence in Financial Reporting to the District, the MWRD Retirement Fund, and to the Retiree Health Care Trust for the Fiscal Year 2008 Comprehensive Annual Financial Reports (CAFR).

The District has received the Distinguished Budget Presentation Award for the **25**th consecutive year. This is the highest form of recognition in government budgeting and demonstrates the effectiveness of the budget as a policy document, a financial plan, an operations guide and a communications device.

The District has received the Certificate of Achievement for Excellence in Financial Reporting for the **34**th consecutive year which puts the District in the top two percent of governments receiving a consecutive award. The MWRD Retirement Fund and the Retiree Health Care Trust have received the Certificate of Achievement for Excellence in Financial Reporting for the **16**th and **2**nd consecutive years, respectively.

These Certificates are the highest form of recognition in the area of accounting and financial reporting by state/local government. The Certificates provide assurance to the District Board and management, and to investors, regulators, rating agencies, the general citizenry and others that the District's financial condition and results of operations are fully and fairly presented.
