In connection with the captioned project, it is necessary to grant a general permit to the District's contractor, Kenny Construction Company (Kenny), for the construction staging area in the North Shore Channel Atlas Parcel 5.01 for Contract 02-010-3S (Rebid), Evanston Intercepting Sewer Rehabilitation - Orrington Avenue Leg.

The consideration for the general permit from Kenny is a nominal fee of ten dollars (\$10.00).
