WHEREAS, Dennis has held the position of President since May of 2002; and

WHEREAS, prior to his election as CFL President, and re-election in 2006, Dennis served as CFL Secretary-Treasurer for six years and for one year as Assistant to CFL President; and

WHEREAS, Dennis J. Gannon is a member of the International Union of Operating Engineers Local 150, where he served as Business Agent from 1991 until joining the CFL in 1995; and

WHEREAS, before working for Local 150, Dennis worked for 17 years at the City of Chicago Department of Streets and Sanitation as a hoisting engineer, foreman and general foreman; and

WHEREAS, Dennis J. Gannon has served on a number of boards and commissions for labor, government and community organizations throughout his career in organized labor; and

WHEREAS, from 1992 until 2004 Dennis served on the Illinois Capital Development Board and previously served on the Illinois Human Resource Investment Council; and

WHEREAS, Dennis currently serves on the Board of Directors of the Amalgamated Bank of Chicago, Blue Cross Blue Shield/HCSC, Citizen Action/Illinois, the Chicago Convention & Tourism Bureau, Chicago Jobs with Justice and United Way of Metropolitan Chicago; and

WHEREAS, Dennis J. Gannon is a member of the Board of Governors of the Metropolitan Planning Council,
