Rental lab coats and coveralls are required to protect laboratory personnel against chemical splashes when they are performing laboratory analytical procedures.

The estimated cost of this contract is \$30,300.00. The estimated 2010, 2011, and 2012 expenditures are \$4,000.00, \$15,000.00, and \$11,300.00 respectively.

A bid deposit is not required for this contract.

The Multi-Project Labor Agreement is not applicable to this contract because it is primarily a furnish and deliver contract.
