#### Dear Sir:

On January 18, 2007, the Board of Commissioners authorized the Director of Procurement and Materials Management to award Contract 06-614-11 Elevator Maintenance at Various Locations to ACM Elevator Company in an amount not to exceed \$587,200.00. The contract expires on May 15, 2010.

As of April 23, 2010, the attached list of change orders has been approved. The effect of these change orders resulted in an increase in an amount of \$153,628.66 from the original amount awarded of \$587,200.00. The current contract value is \$740,828.66. The prior approved change orders reflect a 26.2% increase to the original contract value.

An increase in contract value is being requested at this time to provide funding for a recent extension of the contract term from February 15, 2010, through May 15, 2010.

This change order is in compliance with the Illinois Criminal Code since the change order is due to circumstances not reasonably foreseeable at the time the contract was signed, and is in the best interest of the District.

It is hereby recommended that the Board of Commissioners authorize the Director of Procurement and Materials Management to execute a change order to increase Contract 06-614-11 in an amount of \$18,558.66
