Dear Sir:

On January 3, 2008, the Board of Commissioners authorized the Director of Procurement and Materials Management to issue a purchase order (PO) for Contract 08-105-11 to furnish and deliver helicopter service for a two-year period, to Len Jablon Helicopters, Inc., in an amount not to exceed \$59,538.00. The contract expired on March 31, 2010.

As of February 4, 2010, the attached list of change orders has been approved. The effect of these change orders resulted in a decrease in an amount of \$31,335.50 from the original amount awarded of \$59,538.00. The current contract value is \$28,202.50. The prior approved change orders reflect a 52.6% decrease to the original contract value.

This decrease will close out and reduce the contract value to the final expenditure amount. Furthermore, this contract is no longer needed due to the award of Contract 10-105-12 on April 1, 2010.

This change order is in compliance with the Illinois Criminal Code since the change is due to circumstances not reasonably foreseeable at the time the contract was signed, and is in the best interest of the District.

It is hereby recommended that the Board of Commissioners authorize the Director of Procurement and
