Contract documents and specifications have been prepared for the annual maintenance of automatic external defibrillators (AEDs), complete with accessories, at various District locations for a 36-month period beginning January 1, 2011.

AED units can be used by trained personnel to help restart the heart of a person in cardiac arrest to keep him/her alive, while awaiting the arrival of advanced life support. This contract will provide for the inspection and maintenance of AEDs as required by state law.

The estimated cost for this contract is \$60,000.00. The estimated 2011, 2012, and 2013 expenditures are \$20,000.00 for each year.

The bid deposit for this contract is \$3,000.00.

The Multi-Project Labor Agreement is not applicable to this contract because it is primarily a furnish and deliver contract.
