RESOLUTION FOR BOARD MEETING OF AUGUST 12, 2010

RESOLUTION sponsored by the Board of Commissioners commemorating the induction of Hugh H. McMillan into the NACWA Hall of Fame

WHEREAS, the National Association of Clean Water Agencies ("NACWA"), formerly the Association of Municipal Sewerage Agencies ("AMSA") was established in 1970 by a founding group of individuals representing 22 large municipal sewerage agencies including the Metropolitan Water Reclamation District of Greater Chicago ("the District"); and

WHEREAS, NACWA initially came together to secure federal funding for municipal wastewater treatment and discuss emerging national interests in improving the quality of the nation's waters; and

WHEREAS, NACWA is now a nationally recognized leader in the development of environmental policy and a sought after technical resource on water quality and ecosystem protection issues; and

WHEREAS, Hugh H. McMillan, former two-time General Superintendent of the District, served as a member of NACWA's Board of Directors and as Treasurer from 1981 through 1983; and

WHEREAS, Mr. McMillan was committed to the organization and was largely responsible for NACWA's continued and growing success; and

WHEREAS, Hugh McMillan was an exceptional employee and unmatched leader at the District and NACWA and one in which the District takes great pride in having employed; and

WHEREAS, NACWA has established a Hall of Fame to commemorate the accomplishments of its exemplary members and officers; and

WHEREAS, NACWA has announced the inclusion of Mr. Hugh H. McMillan in the Inaugural Class of

Admission to the NACWA Hall of Fame; and

NOW, THEREFORE, BE IT RESOLVED, that we, the Board of Commissioners of the Metropolitan Water Reclamation District of Greater Chicago, on behalf of ourselves and staff, do hereby commemorate the induction of Hugh H. McMillan into the Inaugural Class of the NACWA Hall of Fame; and

BE IT FURTHER RESOLVED, that this Resolution be spread upon the permanent Record of Proceedings of the Board of Commissioners of the Metropolitan Water Reclamation District of Greater Chicago and that a copy of same, suitably engrossed, be presented to the family of Mr. Hugh H. McMillan.
