Dear Sir:

On February 4, 2010, the Board of Commissioners authorized the Director of Procurement and Materials Management to award Contract 10-699-11, Services of Heavy Equipment with Operators for Material Handling at LASMA and CALSMA, Group B, to M.A.T. Leasing, Inc., in an amount not to exceed \$1,020,000.00. The contract expires on December 31, 2011.

This contract has no prior change orders.

The need for the decrease is due to a less than anticipated need for services of heavy equipment with operators for material handling at CALSMA for the 2010 drying season.

This change order is in compliance with the Illinois Criminal Code since the change is due to circumstances not reasonably foreseeable at the time the contract was signed, and is in the best interest of the District.

It is hereby recommended that the Board of Commissioners authorize the Director of Procurement and Materials Management to execute a change order to decrease Contract 10-699-11, Group B, in an amount of \$45,000.00 (approximately 4.4% of the current contract value), from an amount of \$1,020,000.00, to an

amount not to exceed \$975,000.00.
