RESOLUTION FOR BOARD MEETING OF SEPTEMBER 2, 2010

RESOLUTION sponsored by the Board of Commissioners recognizing the Chatham Business Association's 38th Annual Awards Gala

WHEREAS, this recognition is evinced by the Metropolitan Water Reclamation District of Greater Chicago's adoption and continuing advocacy of a policy which supports the legitimate aspirations of minority communities and businesses within its jurisdiction; and

WHEREAS, the development of minority business enterprises is in the best interests of the Metropolitan Water Reclamation District of Greater Chicago, the State of Illinois and the United States of America; and

NOW, THEREFORE, BE IT RESOLVED, that we, the Board of Commissioners of the Metropolitan Water Reclamation District of Greater Chicago, on behalf of ourselves and staff, hereby join in recognizing the Chatham Business Associations 38th Annual Awards Gala; and
