ATTACHMENT 2

Contract 00-473-1D, “Replace Casework, Fume Hoods and Miscellaneous Work at Egan, Kirie, Stickney WRPs and at the MOB and MOBA”, is 99% complete and is in the Final Punch List phase of the contract. This contract is currently two and a half years behind schedule, largely due to the numerous change orders required to complete the work. These change orders were generally required due to existing conditions, which were not apparent during the design phase. The change orders having the most adverse affect on the contract completion date involved the HVAC systems at the Egan and Stickney WRPs. These change orders included resizing motors and upgrading the HVAC control systems at the Egan WRP and modifying a Roof Top Unit at the Stickney WRP.

Contract 04-824-2P, Tertiary Filter Rehabilitation, Pumps VFDs and Other Plant Improvements at Kirie, Egan and Hanover Park WRPs, is 99% complete and is in the Final Punch List phase of the contract. The majority of the delay on this contract is attributable to two major factors. First, several mechanical and electrical change orders were required at the Kirie WRP that were operational necessities not contemplated during the design phase. These changes had a lengthy submittal and approval process that affected the contract schedule. Secondly, numerous concrete repairs were necessary to the north aeration tanks to make them fully functional in anticipation of an upcoming repair contract on the south aeration tanks. This contract is expected to be closed out in January 2011.
