

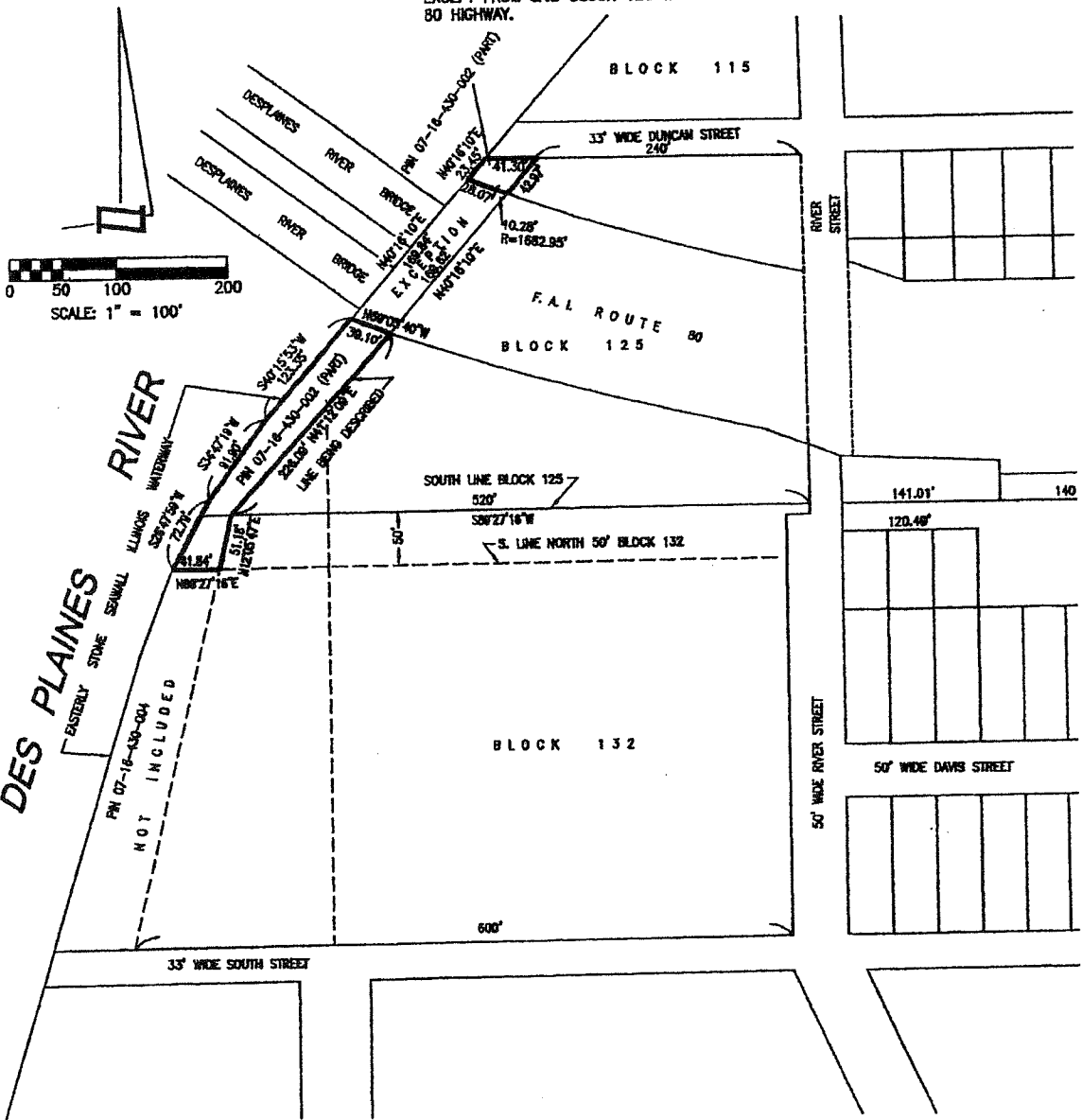

LEGAL DESCRIPTION

THAT PART OF BLOCK 125 AND BLOCK 132 IN SCHOOL SECTION ADDITION TO JOLIET, BEING A PART OF THE SOUTHEAST QUARTER OF SECTION 16, TOWNSHIP 35 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN, CITY OF JOLIET, WILL COUNTY, ILLINOIS, DESCRIBED AS LYING EASTERLY OF THE EASTERLY STONE SEAWALL OF THE ILLINOIS WATERWAY (DES PLAINES RIVER) AND LYING WESTERLY OF THE LINE BEING DESCRIBED AS DRAWN FROM A POINT ON THE SOUTH LINE OF DUNCAN STREET 240 FEET WEST OF THE WEST LINE OF RIVER STREET, TO A POINT IN THE SOUTH LINE OF SAID BLOCK 125, BEING 520 FEET WEST OF THE WEST LINE OF SAID RIVER STREET; ALSO THAT PART OF SAID BLOCK 132, EXCEPTING THAT PART LYING WEST OF A LINE DRAWN FROM A POINT ON THE NORTH LINE OF SAID BLOCK 132, A DISTANCE OF 520 FEET WEST OF THE WEST LINE OF RIVER STREET, TO A POINT IN THE NORTH LINE OF SOUTH STREET, 600 FEET SOUTH OF THE WEST LINE OF SAID RIVER STREET AND EXCEPT THAT PART LYING SOUTH OF THE NORTH 50 FEET OF SAID BLOCK 132, AND ALSO EXCEPT FROM SAID BLOCK 125 THAT PART TAKEN FOR FEDERAL AID INTERSTATE ROUTE 80 HIGHWAY.

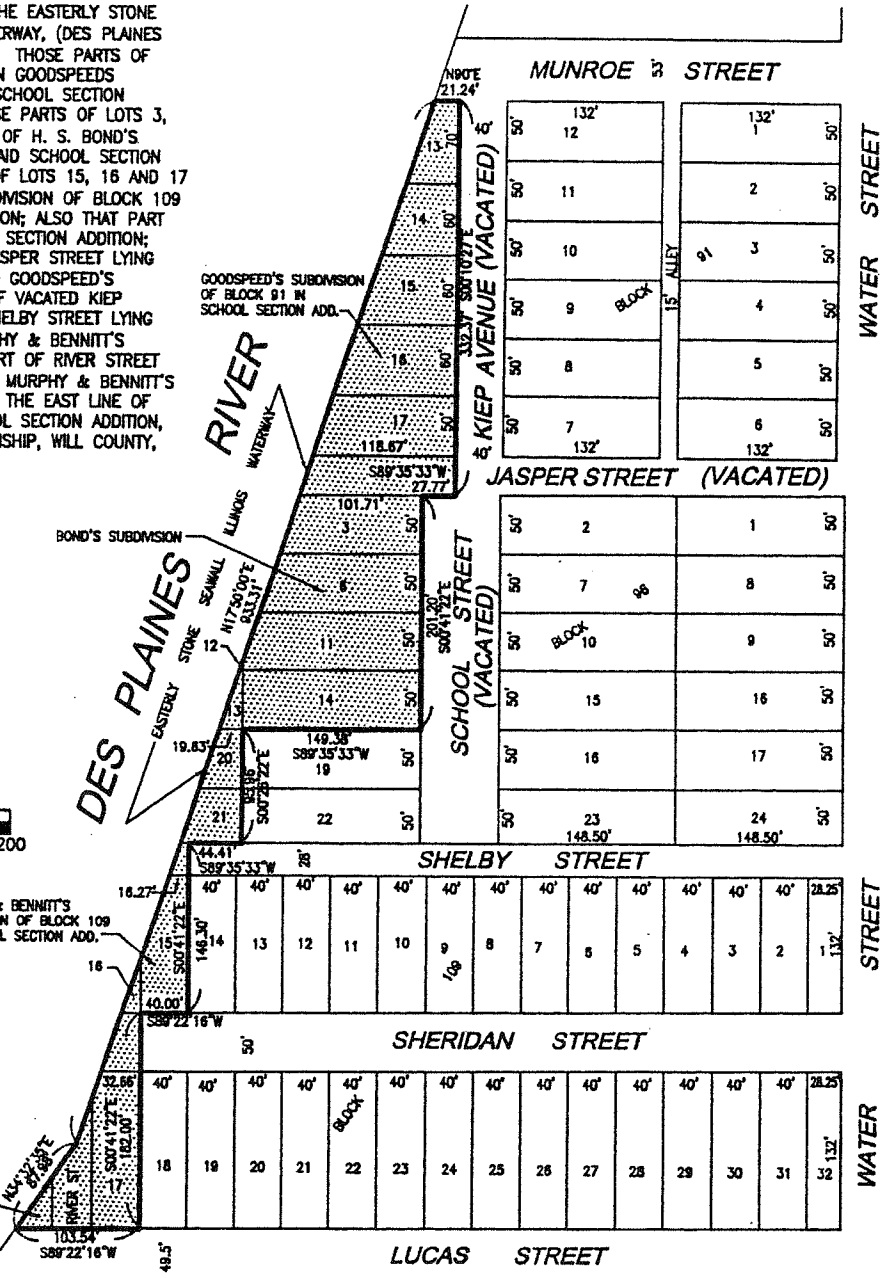
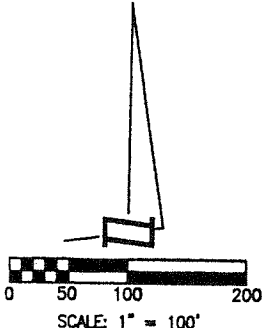
