Request Authority to Review the Proposed Amended User Charge Ordinance of the Metropolitan Water Reclamation District of Greater Chicago

..Body

Dear Sir:

An in-house review of the Metropolitan Water Reclamation District of Greater Chicago's (District) User Charge Ordinance (Ordinance) by the Monitoring and Research Department established the need to amend certain provisions of the Ordinance. To facilitate extended public notice of the proposed changes, it is recommended that the Board of Commissioners (Board) consider the adoption of the revised Ordinance at the regular Board Meeting on November 17, 2022.

The amendments to the Ordinance are proposed as follows:

1. Appendix E, Section I is amended to modify the Minimum Pretreatment Requirement Charges applicable to Significant Industrial Users. The 2023 charges are as follows:

2. Appendix F, Section I is amended to modify the User Charge rates applicable to Large Commercial-Industrial User and Tax-Exempt User classes. The 2023 billing rates for volume, Biochemical Oxygen Demand (BOD) and Suspended Solids (SS) are as follows:

LARGE COMMERCIAL-INDUSTRIAL USER AND TAX-EXEMPT USER RATES:

(1) Volume	\$277.48 per million gallons	\$282.47 per million gallons
(2) 5-day BOD	\$181.07 per thousand pounds of BOD	\$184.33 per thousand pounds of BOD

3. Appendix F, Section III is amended to modify the Operations, Maintenance and Replacement (OM&R) Factor as follows:

2022 OM&R Factor	Recommended 2023 OM&R Factor
0.341	0.401

The recommended rates and OM&R Factor were the result of a collaboration between the District and its industrial community in 2013 to establish a more efficient cost recovery method starting in 2014.

Attached is "The Proposed Metropolitan Water Reclamation District of Greater Chicago's User Charge Ordinance, As Amended November 17, 2022." It is recommended that the Board adopt the proposed Ordinance, as herein amended. The Ordinance, as amended, will take effect on January 1, 2023.
