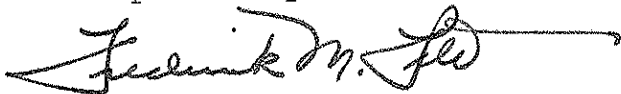
Dear Sir:

Korryene McArthur is a Principal Office Support Specialist at the Stickney Water Reclamation Plant. On January 9, 2004 she slipped and fell on ice in the employee parking lot. She went to Clearing Clinic and was diagnosed with a lower back contusion and a left wrist sprain. MRI of the lumbar spine revealed a bulging L5-S1 disc and degenerative disc disease. MRI of the left wrist revealed a sprain of the pronator quadratus muscle. McArthur had extensive physical and occupational therapy. She lost 19 days of work.

McArthur filed an Application for Adjustment of Claim with the Illinois Workers Compensation Commission being Case No. 05WC 53051. At this time, this case can be settled for the sum of \$9,441.45 which represents a 2-1/2% loss of the person as a whole (\$6,841.63) for the back and a 2-1/2% loss of the left hand/wrist (\$2,599.82).

The General Counsel requests payment of that sum be approved and he be authorized to execute such documents as may be necessary to effect the settlement.

Re: Settlement of the Workers' Compensation Claims of Richard Feiss vs. MWRDGC, IWCC #s 02WC 29468 and 02WC 53335, Illinois Workers' Compensation Commission in the sum of \$2,500.00. Account 901-30000-601090.

Dear Sir:

Richard Feiss was a Storekeeper at the North Side Water Reclamation Plant. On April 1, 2002, he claimed emotional distress due to perceived harassment at work. On August 19, 2002, Feiss filed a second stress claim after an argument with his supervisor. Feiss' doctor claimed he suffered from extreme depression and severe anxiety due to the work incidents.

These claims were denied by the District. At this time Feiss has agreed to settle all issues on both claims for the sum of \$2,500.00. Due to the costs associated with a trial at the Illinois Workers' Compensation Commission including bringing in witnesses to refute Feiss' claims, the General Counsel believes this settlement to be in the best interests of the District and requests authority to execute such documents as may be necessary to effect the settlement.
