Settlement of the Workers' Compensation Claim of James Mitchell vs. MWRDGC, Case No. 10 WC 13586, Illinois Workers' Compensation Commission (IWCC), in the sum of \$3,788.90. Account 901-30000-601090

Dear Sir:

James Mitchell is a Laborer Foreman at the Stickney Water Reclamation Plant. On March 15, 2010, while performing his duties, he sustained an injury to his right middle finger.

Mr. Mitchell received emergency room treatment and was given temporary modified duty work with a diagnosis of dislocated right middle finger. He underwent conservative care, which included activity modification, physical therapy, and anti-inflammatory medication. He did not lose any time from work.

Mr. Mitchell filed an Application for Adjustment of Claim with the IWCC through his attorney. Subject to the approval of the IWCC, this claim can now be settled in an amount of \$3,788.90, which represents approximately 15% loss of use of the right middle finger. This would close out any future medical exposure on this claim.

The General Counsel believes this settlement is in the best interests of the District and requests payment of that sum be approved and he be authorized to execute such documents as may be necessary to effect the settlement.
