Issue purchase order to CDW Government LLC, to Furnish and Deliver FireEye Licensing and Support, in an amount not to exceed \$86,600.00, Account 101-27000-612840, Requisition 1563201

Dear Sir:

Authorization is requested to issue a purchase order to CDW Government LLC to furnish and deliver Web Security Platform and Support for a one-year period. The contract starts June 14, 2021 and ends June 13, 2022.

The Web Security Platform provides real-time, dynamic threat protection against the next generation of cyber-attacks to protect an organization across the primary threat vectors, including web, email, and files. This Web Security Platform supplements the security provided by traditional defenses, such as next-generation firewalls, intrusion protection systems, anti-virus, and gateways.

On February 22, 2012, The City of Chicago advertised a Request for Proposal (RFP) for “Computer Hardware, Software Peripherals and Related Maintenance and Installation Services” in collaboration with the Cook County. Multiple responses were received by the proposal due date of June 6, 2012. CDW Government LLC was awarded the three-year contract effective October 1, 2014, with an option to extend the contract for two additional one-year terms. On September 28, 2017, the City of Chicago contract was extended to September 30, 2019. On September 24, 2019, the City of Chicago Contract was extended to September 30, 2021. Article 10) General Conditions, Section j) “Governmental Joint Purchasing Agreement,” allows other government agencies to purchase goods or services under this contract.

CDW Government LLC has submitted prices for the Web Security Platform and Support for a one-year period per the established contract discount percentages. Inasmuch as CDW Government LLC is the only source of supply for the FireEye Web Security Licensing and Maintenance for a one-year period under this agreement,

said purchase order may be issued without competitive bidding pursuant to Section 11.4 of the Purchasing Act.

CDW Government LLC is registered and in good standing with the State of Illinois.

The Multi-Project Labor Agreement is not applicable to this contract because the classification of work does not fall within the provisions of the MPLA.

The Affirmative Action Appendix A and Appendix V are not included in this contract because the estimate is less than the minimum threshold by Section 4 of the Affirmative Action Ordinance.

In view of the foregoing, it is requested that the Director of Procurement and Materials Management be authorized to issue said purchase order to CDW Government LLC in an amount not to exceed \$86,600.00.
