Authorization is requested to issue a purchase order to 72 Hour LLC, dba National Auto Fleet Group to furnish and deliver one 2018 Ford Expedition under the NJPA Purchasing Contract No. 120716-NAF. The District has the ability to participate in NJPA Contracts under the Government Joint Purchasing Act, 30 ILCS 525/0.01 et. seq.

The NJPA currently has a competitively bid contract with 72 Hour LLC, dba National Auto Fleet Group for the purchase of 2018 Ford Expeditions with gasoline engines. On May 19, 2011, the Board of Commissioners granted authority to participate in the NJPA purchasing cooperative. The invitation to bid was issued to establish a contract to enable all state agencies and authorized local governmental units to purchase current model year production vehicles during the contract period. The term of the contract began on January 17, 2017 and expires on January 17, 2021. 72 Hour LLC, dba National Auto Fleet Group is registered to do business in the state of California.

The below planned vehicle replacement has exceptionally high lifetime-to-date maintenance costs and is near the replacement criteria of 10 years and/or 100,000 miles:
