Request for Proposal 18-RFP-14 documents have been prepared for Third Party Claims Administrator Services, at the request of the Human Resources Department. The service agreement(s) will be effective on April 15, 2019.

The purpose of this contract is to obtain services to administer claims for the District in two categories: Category 1) Workers' Compensation claims and related services; and Category 2) Non-litigated Liability claims and related services.

Vendors will be required to submit a proposal for the services requested in this RFP and must submit a proposal for both Category 1) Workers' Compensation claims and related services, as well as Category 2) Non-litigated Liability claims and related services. Category 2 services will be on an as-needed basis.

The estimated cost for this RFP is \$810,000.00. The estimated expenditures for 2019 is \$248,500.00, for 2020 is \$250,000.00, for 2021 is \$250,000.00, and for 2022 is \$61,500.00.

A bid deposit is not required for this RFP.
