MEMORIAL RESOLUTION sponsored by the Board of Commissioners celebrating the life of Mrs. Irene Crayton-Unokiwe

WHEREAS, at the age of seven, Mrs. Crayton-Unokiwe migrated north with her family, from Vicksburg, Mississippi to Chicago, Illinois. Mrs. Crayton-Unokiwe attended John Marshall High School, where she flourished. Following graduation, she earned her Bachelor of Science degree from the University of Chicago; and

WHEREAS, after earning her degree, Mrs. Crayton-Unokiwe decided to pursue her dreams and begin the next chapter of her life in Cleveland, Ohio. And pursue her dreams she did.
