Request for Proposal documents have been prepared for Contract 21-RFP-08, GASB 87 Lease Accounting Software, at the request of the Finance Department. The contract begins May 31, 2021 and ends June 1, 2024.

The purpose of this contract is to obtain a hosted accounting software package compliant with GASB 87, Leases, that can calculate lease receivable/payable, deferrals, interest income, and lease revenue for all leases and easements where the District is the lessor or lessee.

The estimated cost for this RFP is \$85,000.00. The estimated 2021, 2022 and 2023 expenditures are \$45,000.00, \$20,000.00, and \$20,000.00 respectively.

A bid deposit is not required for this RFP.
