PUBLIC NOTICE

In accordance with the requirements of the United States Environmental Protection Agency in 40 CFR 403.8(f)(2)(viii), the Metropolitan Water Reclamation District of Greater Chicago (District) herewith provides notification to the public of those industrial dischargers to its system which were determined to be in significant noncompliance of applicable Pretreatment Standards or Other Requirements during the period from January 1, 2024, to December 31, 2024.
